McLean Citizens Association Resolution
Support for Unfunded School-Related Sidewalk Projects
November 20, 2013

Whereas, there is a lack of sidewalks on the segments of Kirby Road, Chesterbrook Road, Idylwood Road, Magarity Road, Lisle Avenue, Brawner Street, Westmoreland Street, Olney Road and Peabody Drive referenced below, and this lack of sidewalks creates dangerous situations and greatly impedes the walkability of community neighborhoods; and

Whereas, there are schools near these segments of road, including Chesterbrook Elementary School, Longfellow Middle School, Lemon Road Elementary School, Franklin Sherman Elementary School, Kent Gardens Elementary School, and Westgate Elementary School, and children who walk along these segments of road face these unsafe and dangerous conditions; and

Whereas, adults, as well as children, face these unsafe conditions and construction of walkway projects along these segments is desirable to create a walkable community for residents of all ages; and

Whereas, these walkway projects are included on the Fairfax County Unfunded Transportation Projects list;

Now, therefore be it resolved, that the McLean Citizens Association strongly supports the construction of sidewalks along the following road segments, listed by project number:

- 1) #96- Brawner St in front of Franklin Sherman elementary School from Calder Rd to Julia Ave
- 2) #105 - One side of Chesterbrook Road between Kirby Road and Golden Court,
- 3) #106 - One side of Chesterbrook Road between Golden Court and Maddux Lane,
- 4) #107 - South side of Chesterbrook Road between Chesterbrook Vale Court and N. Albemarle Street,
- 5) #136 - East side of Idylwood Road from Norwalk Street to existing walkway two properties to the south,
- 6) #137 - West side of Idylwood Road from Hillside Drive to Idylwood Court,
- 7) #140 - South side of Kirby Road between Chesterbrook Elementary School and Halsey Road,
- 8) #141 - South side of Kirby Road between Halsey Road and Franklin Avenue,
- 9) #142 - North side of Kirby Road between Ivy Hill Drive and Corliss Court,
- 10) #143 - North side of Kirby Road between Chesterfield Avenue and Ivy Hill Drive,
- 11) #147 - South side of Lisle Avenue from Griffith Road to Sportsman Drive,

- 12) #150 - South side of Magarity Road from Lusby Place to Peabody Drive,
- 13) #159 - Olney Road existing sidewalk replacement from Magarity Road to Lisle Avenue,
- 14) #160 – East side of Peabody Drive from Magarity Road to Lisle Avenue.
- 15) #186 – West side of Westmoreland St from Kirby Rd to Lemon Rd
- 16) #203 - North side of Idylwood Road from Friendship Lane to Stephanie Marie Drive.
